Following the approval of the Eastern COVID Coordination Office, Dewathang, Samdrupjongkhar Dzongkhag's COVID-19 Task Force is hereby pleased to announce the unlocking of the Dzongkhag in Phase wise with effect from 8:24 am of 20th September 2020. The details of the unlocking are mentioned below:



Staying at home is the most effective measure to keep ourselves safe from the virus. NOTIFICATION

This is to notify the general public on the following in addition to the phase wise unlocking notification issued via notification no. SDA/COVID-19/secretariat/2020-21/998 dated 20th Sept, 2020.

1. Individual/families are allowed to move out from 5:00 am to 7:00 pm (in phase I)
2. Individual/families are allowed to move out from 5:00 am to 8:00 pm (in phase II)
3. All people residing in Old NHDCL colony including primary contacts of the index COVID-19 positive case were tested negative during the two times mass testing carried out by the Samdrup Jongkhar Medical Desk. Therefore, phase- I is applied to those people residing in the colony.
4. RBP colony which has been categorized yellow zone shall remain in the containment mode until further notice.
5. Zoning system shall be superceded by the phase wise unlocking.
6. Except for delivery in the yellow zone (RBP Colony), all identified essential delivery vehicles shall be withdrawn with immediate effect.
